COVID-19 SAFETY PROTOCOLS/WAIVER

WELCOME BACK TO DANCE EVERYONE! We are all so excited to dance together in person again but we do want to make sure it's done as safely as possible for both students and staff. The following are safety protocols we want to make sure all parents and students are aware of, understand and agree to.

****PLEASE READ EACH NEW SAFETY PROTOCOL CAREFULLY AND SIGN BELOW THAT YOU UNDERSTAND AND AGREE TO ALL MEASURES WE ARE TAKING TO TRY AND KEEP EVERYONE HEALTHY AND SAFE. ****

PLEASE PUT YOUR INITIALS by each safety measure below showing you read it and agree to it. Then please sign at the bottom. Thank you.

_____ I agree to keep my child home from dance if they or any person they have been in contact with has a cough, fever or shortness of breath.

_____ I agree to talk to my child about the importance of going to their home base color coded chair upon arriving to class and then to the corresponding colored X out in center floor to dance when instructed to do so. Also to wash their hands thoroughly if they need to use the restroom during class. Please let them know we can all talk, laugh and interact together as always but we just have to keep our distance for a while longer.

_____ I understand that if the teacher sees dancers touching their face they will remind the dancer to please use some hand sanitizer. Please explain that is for their own safety.

_____ I agree to keep my child with me in the parking lot until the previous class is dismissed and the teacher motions the next class to enter.

_____ I understand that if my child's class is in Room B I will be bringing her/him to the front door for entering and exiting. If their class is in Room C I will be bringing her/him to the back door. This should cut down on congestion entering and exiting and in the lobby. I can find room info listed on signage outside the studio, listed on face book and on the new schedule given out before classes resume.

_____ I understand that both the lobby and dressing room are closed and parents will be allowed in for business ONE PARENT AT A TIME to ensure proper social distancing.

_____ I understand that B&W will be following the government mandate on adults wearing masks in the building but dancers will not be required to wear one, as they will be kept at a safe distance from one another and it will be easier to dance without one. It will also cut down on them touching their face.

_____ I understand that parents should maintain 6 feet distancing in the parking lot.
